# Entry Details

To enter, complete the requirements as stated in this nomination kit/online platform. Entrants can be nominated by their organisation, a third party or be self-nominated.

To nominate someone other than yourself, email [events@udiawa.com.au](mailto:events@udiawa.com.au). For nominations, we will send the nominee an alert of the nomination and they will complete the process from there. Nominations can remain anonymous.

## ELIGIBILITY

To be eligible for the UDIA WA Women in Leadership Award applicants must:

- be from a current financial member of UDIA WA;
- be based in WA and be available for an interview in Perth if required;
- have a minimum of 10 years experience in the development industry or an associated industry; and
- complete requirements as stated in this nomination kit/online platform by Friday 1 July 2022.

## JUDGING PROCESS

The UDIA WA Council will assess all submissions based on the criteria and determine a shortlist of finalists. All nominees will be emailed announcing the shortlist of finalists. Finalists will then be contacted by UDIA WA to arrange a time for them to meet with the UDIA WA Council representatives for an interview.

After all finalists have been interviewed, the UDIA WA Council representatives will contact referees before determining the winner. The 2022 winner will be announced at the 2022 UDIA Awards for Excellence Gala on Saturday 17 September. The Council's decision is final and no further correspondence will be entered into. Additional merit can be awarded at the Council's discretion.

  - How you act as a role model to other professionals.
  - Positive contributions and influence that you have made to your organisation/the development industry, above and beyond your job role.
- Your CV (maximum five A4 pages)
- Your hi-res headshot (min size 1MB)
